What to Expect During Your EMG/NCS Test

► Why have I been referred to Bingham Nerve and Muscle?

You have been referred to Bingham Nerve and Muscle because you have experienced numbness, tingling, pain, weakness and/or muscle cramping. If your provider suspects that you may have a problem with your nerves or muscles, this procedure will likely be an important part of your evaluation. This procedure takes about 30 minutes.

► What kind of training do EMG/NCS doctors have?

- Four years of college
- Four years of medical school
- Four years of residency training in physical medicine and rehabilitation (physiatry)
- Board certification in physical medicine and rehabilitation
- Board certification in electrodiagnostic medicine (ABEM)

► How should I prepare for these tests?

Please take a bath or shower to remove oil from your skin. Do not use body lotion or powder the day of your test to improve the quality of the test results. Also, to save time, you may download and complete our patient information forms on our website, nerveandmuscle.com, and bring them with you to your appointment.

► Nerve Conduction Studies

Nerve conduction studies show how well an electrical signal travels across a nerve. Special equipment records how the nerve works. The doctor may test several nerves.

► Electromyography

In this part of the exam, the doctor evaluates the electrical signals that travel from the muscle to the EMG monitor. A small electrode will be placed just under the skin in a few different muscles. With new technology and special techniques, this procedure can be done with minimal discomfort.

► When will I know the test results?

The physician will need to study the test results after you leave the office. Therefore, he may not be able to discuss your results. Typically, formal reports are faxed to your doctor within 48 hours. We will provide your physician with an accurate diagnosis so that you can enjoy a speedy recovery.

► Financial Policy

At Bingham Nerve and Muscle, we accept all forms of health insurance including Medicare, Medicaid (TennCare), and TriCare. We are also in-network with most commercial carriers. If you have questions about your specific insurance, feel free to call our billing department for assistance.
